WHEREAS, the County Commission has previously adopted an Order Regulating the Operation of Food Establishments and Providing Penalties in the County of Lawrence, State of Missouri (the "Food Establishment Order"); and

WHEREAS, the County Commission desires to amend, modify, and update the WWTS Ordinance and the Food Establishment Order as provided for herein.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE COUNTY COMMISSION OF LAWRENCE COUNTY, MISSOURI AS FOLLOWS:

- 1. <u>Recitals.</u> The County Commission confirms that the recitals, statements and reasons set forth above are the findings of the County Commission regarding the subject matter set forth in this Order.
- 2. <u>Authorization and Approval WWTS Ordinance</u>. The County Commission hereby promulgates, adopts, authorizes and approves the WWTS Ordinance, as recommended and requested by the Lawrence County Health Department in the form attached to this Order as <u>Exhibit A</u>, which is attached hereto and incorporated herein by reference.
- 3. <u>Authorization and Approval Food Establishment Order</u>. The County Commission hereby promulgates, adopts, authorizes and approves the Food Establishment Order, as recommended and requested by the Lawrence County Health Department in the form attached to this Order as <u>Exhibit B</u>, which is attached hereto and incorporated herein by reference.
- 4. <u>Printing; Availability</u>. The County Clerk is hereby requested and ordered to print Exhibit A and Exhibit B and make available for distribution to the public in the office of the County Clerk. Exhibit A and Exhibit B shall also be made available for inspection and viewing at the following websites: www.lawrencecountymo.org and www.lawrencecohealth.com.
- 5. <u>Publication</u>. The County Clerk is hereby requested and ordered to require a copy of this Order to be published in some newspaper in the county for three successive weeks, not later than thirty days after the entry of this Order.
- 6. <u>Effective Date</u>. This Order shall be in full force and effect on the date it is approved by the County Commission.
